Meeting Minutes.

1. The meeting was called to order at 5:40 PM. Attending for the committee: Alan Chaney, Philip DeNyse, and Dana Metzler. Absent was Joe Dean. Also attending was James Tully, BOS.
2. The committee reviewed the minutes of January 22, 2019, there were no additions or corrections. The minutes were adopted 3-0 and will be posted to town web site.
3. Committee Administrative Issues.
 - a. Bylaw Status. Mr. DeNyse reported he was informed by the Town Clerk the bylaw is still under review by the Commonwealth. They have until September to complete the review process.
 - b. Alignment of Committee name to Bylaw Designation. The committee discussed the name of the committee as it been expressed as "Memorials

and Monuments” and “Monuments and Memorials”. The committee was in agreement for clarity the name of committee should align to the bylaw nomenclature. Therefore the committee shall be referred to as “Monuments and Memorials Committee”.

- c. Proposals for Amendments to the Bylaw: Length of Terms. There was discussion the bylaw does not describe the length of the terms for the five members. It was observed the bylaw could be amended or the Board of Selectman could designate the term lengths. Mr. Metzler suggested the Board of Selectman designate the duration of the terms in a staggered duration to ensure continuity of knowledge of the committee’s activities. A recommendation will be made to the BOS.
 - d. Membership of the Committee. The Town Clerk has asked each committee to designate positions within the committees. After discussion, Mr. Chaney who has held the chairmanship since the inception of the committee, recommended a change and Mr. Dean be nominated as chairperson for the coming year. All present were in favor of the by a vote of 3-0.
4. Monument and Memorial Administration.
- a. Relocation of the Richard C. Mitchell granite bench located on the Swallow Union playground at the request of the Parks Commissioners. The committee discussed the need and rationale for the change. Mr. DeNyse provided some documentation of the previous location and the planned new location. Refer to Enclosure 2. The committee members were persuaded this monument should be relocated to the recommended locale. The committee members were of unanimous thought on this action. This recommendation to be provided to the Board of Selectman for their review and for addition to the next Town Meeting warrant if the Board recommends.
 - b. Relocation of the Robert Rockwell Memorial Sign. Movement of the Rockwell sign was discussed and if the sign should be moved to another location, if so what location. Some committee members were not convinced the present circumstance of the monument were sufficient to warrant relocation. Lacking in the discussion was the compelling motivation to move the monument from the current location. The secondary concern, was where to move the monument. A number of different options were discussed. There was no support for moving the monument to the grassy area behind the Town Hall. Other options included placing on the Town Common, on a new traffic island elsewhere

- in the town. Lacking any consensus, this issue was table for further discussion at the next meeting.
- c. Relocation of the Vernon English monument. There was discussion on moving this monument. Committee members were not clear on rationale for relocation or what the potential locales could be. Committee members tabled the issue for future discussion when Mr. Dean will be present.
 - d. Review and Update of the Master Monuments and Memorial Master List. Mr. DeNyse offered some minor updates to the master list. This list is included as an enclosure.
5. The meeting was adjourned at 6:24 PM. The next meeting has not been scheduled.

VI. Robert Rockwell Memorial

The Robert Rockwell Square is just across the street from the Watering Trough on Main Street. There is only a sign that has badly faded and is need of replacement. This committee recommends that it be replaced to look like the original sign. Robert Rockwell of Dunstable was a World War II paratrooper who during the Normandy Invasion was injured and captured by the Germans. He later died in a German field hospital. The sign is currently across from the Watering Trough next to the road and is not the original. During the site visits members of the committee were interested in locating the original sign with the hope that the older one might be in better shape or easily restored. Additionally it probably should be moved to the triangle on the corner so it would receive more visibility.

IV. Vernon English Square

The Vernon English Square is located on the corner of Pleasant Street and Brook Street.




This monument is hardly ever seen as it is quite small and easily missed. Vernon English was a Korean War Veteran. Vernon English (19 Feb 1932-8 Jun 1951) was son of William and Nina English. Sgt. English was a Cannoneer for the 15th Field Artillery Battalion, 2nd Infantry Division. He was taken prisoner on 13 Feb 1951 and died in prison camp 8 Jun 1951, in Korea. He was awarded the Prisoner of War Medal; Korean Service Medal; United Nations Service Medal; Nation Defense Service Medal; Korean Presidential Unit Citation and Republic of Korea War Service Medal. He is buried in Central Cemetery. This committee recommends that if a Dunstable Memorial Park is built it be moved there.
