2. Rake and seed damaged areas. Cost of and who does? Done by Jean Phelan with the help of Natural Matters. Cost from Natural matters absorbed under previous approve contract work. Cost around \$500 including grass seed.

3. Prune branches off of large shed at Larter. Done by Brian Locapo- no cost

4. Prevailing wage issues and cost and discussion of. Irrigation in particular. Discussed, no conclusions made

5. Turf treatments and maintenance, aerating and seeding completed. Larter field, Town hall, Common and Police station. Completed

6. Pollinator Garden at Larter. Feasibility of. Discussed new garden not feasible but discussed existing areas on slopes already pollinator friendly and cultural practice on turf can enhance pollinator and bird activity.

7. 2024 and 2025 budgets and 2025 increase request reviewed. 2024 budget sheet provided and reviewed. Decided to continue plowing Larter track and agreed that was a priority over future turf treatments as 2024 budget has mostly been exhausted.
