This property abuts existing conservation land with two or three building lots on High Street. Approximately 48 acres off of High Street for \$320,000.

- 1. Massachusetts Land Grant: \$192,000
- 2. CPA Undesignated Fund and Open Space Fund: \$118,000
- 3. Transfer from the Timber Fund: \$10,000

The \$192,000 state land grant must be secured for this purchase to move forward.
