# Conservation Commission Minutes Monday, May 23, 2022

Chair Alan Chaney called the meeting to order at 6:30pm. Members present: Al Starbird, Leah Basbanes and Marijan Andacic Members absent: Kate DeLoureiro, Juan Amodei and Tiffany Naughton

# <u> 179 Off Pond Street – Wall Repair – Carly Yezzi</u>

Ms. Yezzi explained that she has an existing wall on Massapoag Pond that has collapsed in areas. The wall, damaged from boat wakes and winter ice, has become unstable. She is looking for direction on what type of material to use (natural fieldstone, concrete, etc.) since the wall abuts the water. Leah said that Ms. Yezzi should probably hire a wetland consultant and must file a Notice of Intent for the proposed repair. The area is a wetland (Massapoag Pond), is land under a waterway, land subject to flooding, a bank and Bordering Vegetated Wetland. Leah said that the Department of Environmental Protection no longer likes to see hard solutions like concrete or rock. They now favor soft solutions like natural vegetation. Leah told Ms. Yezzi that she probably needs an engineered wall, possibly with footings to hold back the area and support the harsh environmental pressures. Ms. Yezzi will contact a wetlands consultant who can design an appropriate wall and is familiar with filing Notice of Intents.

# Meeting Minutes of May 9, 2022

Leah made a motion to approve, as submitted, the May 9 meeting minutes. Marijan 2<sup>nd</sup> the motion. – Motion passed unanimously.

No bills. Al made a motion to sign payroll. Marijan 2<sup>nd</sup> the motion. – Motion passed unanimously.

# Results of Site Visit to 285 Pleasant St. – Robert Ramirez– Possible Violation

Mr. Ramirez called on Thursday the 12th at 3:07pm, when the office was closed, to say that he would not be at home Saturday (14<sup>th</sup>) and asked if members could come out that night instead. Since members did not receive the message until Monday the 16th; Alan, Marijan and Leah went out as originally scheduled on Saturday at 3pm. Mr. Ramirez called the office Wednesday the 18th asking to reschedule the site visit. He was emailed the agenda that contained the Zoom information for tonight's meeting. He was asked to log on to discuss his property, and possibly set up another site visit. He did not attend. Leah did say that there are some issues at the property. amount of fill and may even be within 25 feet of a wetland. Members agreed that they would like to meet Mr. Ramirez at the site this week either Friday or Saturday.

### Community Preservation Member for 20222-2023 – Al Starbird

Al agreed to stay on as the Conservation Commission's representative on the Community Preservation Committee. Leah made a motion that the Board of Selectmen appoint Al Starbird for the 2022-2023 fiscal year. Marijan 2<sup>nd</sup> the motion. – Motion passed unanimously.

### **Open Space Definitive Subdivision Hearing – 0 River Street – Coljack Development**

The Commission will review the filing however Alan said that he does not see any issues as presented.

### Signing of Boardwalk Contract to Apply for Grant – Fiscal Year 2023

Marijan made a motion to authorize Alan Chaney to sign the contract for the engineering firm of Hoyle Tanner to delineate the wetlands, file the Notice of Intent and prepare the grant application in time for the February 2023 deadline. Al 2<sup>nd</sup> the motion. – Motion passed unanimously.

#### 61 and 67 Valley Street – Possible Wetland Violations
