Trees in the Area of the Stone Arch Bridge

Jeff brought up that there are trees that are leaning over the trail near the Stone Arch Bridge however, after discussing; members believe they are on private property.

Pleasant Street Extension Site Visit

Alan and Jeff met with Darrell Oakley from New England Power Company to discuss the 400 feet of bridge and poles lying within the wetlands near the company's station. All agreed that the materials are a significant violation of the Massachusetts Wetland Law. Mr. Oakley agreed to put up no trespassing signs and suggested that the Commission call the state environmental police to stakeout the area in search of riders violating the state motorized vehicle law. Chapter 266 Section 121A of Mass General Law states "Whoever, without right, enters upon the private land of another, whether or not such land be posted against trespass, and in so entering makes use of or has in his immediate possession or control any vehicle, machine, or device which includes an internal combustion engine or other source of mechanical power, shall be punished by a fine of not more than \$500." Mr. Oakley doesn't believe the poles belong to New England Power. The Commission decided that they will need to identify the owners of the poles (New England Power or Telephone Company) and will address having them removed once that is done.

August 14, 2017 Meeting

Due to the fact that there may not be a quorum on August 14th, the Commission decided to cancel their meeting that week if no agenda items are scheduled by the first week of August.

Motion was made to close the meeting at 7:42pm. Motion was 2nd. Motion passed unanimously. The next meeting of the Dunstable Conservation Commission is scheduled for Monday, August 28, 2017, 6:30pm at the Dunstable Town Hall.
