Meeting Minutes – July 24th

Westford Street Grant Update

Kendall Cranberry Bog Grant Application Update

Melissa Cryan from the Department of Conservation and Recreation met Alan Chaney and Bob Kennedy out at the Kendall Cranberry Bog site. After walking the property they took Ms. Cryan out to see the Stone Arch Bridge. The Conservation Commission should hear this fall if they were awarded a grant.

Black Brook CR Lots – Westford Street

The Administrative Assistant noticed that the builder(s) of some lots on Westford Street affected by a Conservation Restriction did not reference the document on the deeds when they transferred the property to the new homeowner. The CR and map were filed at the North Middlesex Registry of Deeds under Book 8441, Page 275 and Plan Book 193, Page 69. There was discussion about notifying the residents and having their properties surveyed in order to establish the restriction line.
