# **Conservation Commission Minutes Monday, October 22, 2018**

Vice Chairman Alan Chaney called the meeting to order at 6:31pm

#### Conservation Restriction - Russell Family - Thorndike Street

The Administrative Assistant received the draft conservation restriction earlier in the day and emailed it to members for review. The Commission went over the draft with the Russell's (and their Attorney Cornelius Sullivan) with all parties agreeing to changes made at the meeting. A section needs clarification so Attorney Sullivan will contact the Town's attorney Brian Falk to discuss this.

#### <u>Update on Alan's Site Visit to Flat Rock and Stone Arch Bridge</u>

Alan reported that he met with Carl Shattuck at Flat Rock Hill. Mr. Shattuck told Alan that he could add  $1\frac{1}{2}$ " crushed stone to repair the ruts, making the entrance easier for the public to use. Alan will also take some of the stone over to the Stone Arch Bridge to repair one area. Juan made a motion to approve the expenditure of \$1,655 for Mr. Shattuck to bring in stone to repair the Flat Rock Hill Conservation area roadway. Tara  $2^{nd}$  the motion. – Motion passed unanimously.

#### **Westford Street Conservation Area Trail Marking**

Alan reported that the trails have been brush hogged and the signs are on order.

#### **Craven Conservation Area**

Jeff Haight had previously mentioned that it might be a good idea to mow the ½-acre field in order to keep the parcel open. Members agreed that the next time John Cover is hired to mow the Unkety Brook Conservation area, we should have him do this also.
