<u>Discussion with Massapoag Rod & Gun Club - Fees</u>

Results of Site Visit - Clearing Trails at Area Behind Swallow Union School

Marijan, Alan and Kate met Nicole Pelletier to walk the area behind Swallow Union Elementary School. Ms. Pelletier thought it would be a good project to have the 4th graders neaten up the existing trails. There is a bridge in the area that needs replacement. That could be a future Eagle Scout project. Marijan made a motion to allow Ms. Pelletier's group to improve the trail system behind the Swallow Union School. Tara 2nd the motion. – Motion passed unanimously.

Results of Site Visit - 20 Swallow Lane - Removal of Trees

Alan and Leah met Ms. White at the site. Alan and Leah discussed removal of the marked trees except for the very large white oak that is shading the brook. Removing that tree could cause a stabilization issue with the embankment. Leah said they could remove the lowest limb on the oak that goes toward the house. The Whites cannot stump any of the trees; however, they may grind the stumps. In addition, the two piles of grass clippings and brush behind the shed must be removed from the area. Only natural vegetation from the bottom to the top is allowed on the embankment. Leah made a motion to send a letter to the homeowners. Al 2nd the motion. – Motion passed unanimously.
