# **Discussion and Vote on Boardwalk Design for Drew Landing**

Earlier in the week, some members went to Nashua to look at the modular boardwalk that Joe Ripley discussed at the last meeting. The structure he is proposing for Dunstable would be similar. The Commission then discussed and voted on the design elements of the boardwalk.

Leah made a motion to use **helical piles** as the foundation type. Al 2<sup>nd</sup> the motion. – Motion passed unanimously.

Juan made a motion to use **modular** as the framing type. Kate 2<sup>nd</sup> the motion. – Motion passed unanimously.

Leah made a motion to use **pressure treated** for decking material. Juan 2<sup>nd</sup> the motion. Motion passed unanimously.

Leah made a motion that a bump out and bench (for resting/birdwatching) be part of the project design depending upon cost. Juan 2<sup>nd</sup> the motion. – Motion passed unanimously.

Members also decided that the boardwalk will be straight (no bends or curves), 8-feet in width, have curbing on the sides and be as low as possible but keep the boardwalk away from high water line.
