<u>Meeting Minutes – September 18, 2017</u>

Joe made a motion to approve the minutes of the September 18th meeting. Eric 2nd the motion. – Motion passed unanimously.

Review/Sign Bills and Payroll

Two 53G invoices and payroll were signed.

Acknowledgement of Ethics Materials

The Board received (by email) ethics materials from the Town Clerk and signed their acknowledgements.

F.Y.2019 Budget

After discussing the fiscal year 2019 budget, George made a motion to request an increase of \$250 bringing the budget amount to \$1,250. Joe 2nd the motion. – Motion passed unanimously.

Alexander Way Update

The Administrative Assistant told members that road acceptance of Alexander Way will not be on the warrant for the November 2017 Special Town Meeting.

Joe brought up that the entrance to Alexander Way lacked curb appeal due to the grade of the street which left steep embankments on the sides of the road. Large rocks were placed to keep the hill from eroding. Weeds will soon grow through the rocks. The Board would like to eliminate unsightly entrances in the future. Josh mentioned that the Board could request developers to submit a rendering of the entrance way so the Board would have an idea of how it will look. Josh also told members that there are published guidelines for steepness which the Board will review at a future meeting.

Bear Hill Estates Subdivision Update

The Administrative Assistant told members that Jeff Rider has been out to the Subdivision a number of times at the request of the developers. The cistern was
