

Addendum #1: Invitation for Bids - Mowing, Landscaping, and Field Maintenance Services

This addendum modifies the original solicitation as described. The addendum may contain supplemental information, clarifications to the solicitation, or substantive changes to terms and conditions, unit pricing, or submittal dates and times. Those submitting a response to the solicitation are required to sign and acknowledge this addendum and include the form in the response. Failure to do so may result in rejection of the response.

Purpose: The Town of Dunstable is seeking bids for Mowing, Landscaping, and Field Maintenance Services.

Addendum to Specification: This addendum is issued to correct the dates contained on the Bid Submission Sheet. In the column labeled "term cost" the dates previously read "April 1, 2029 – December 1, 2029." They have been corrected to read "April 1, 2028 - December 1, 2028." To be clear, prospective bidders are submitting bids for a contract for 2 years and 8 months.

A new Bid Submission Sheet is attached to this addendum and should be used to replace the one contained in the IFB.

Firms that intend to submit a proposal must include the Addenda Acknowledgement Form with their response and must acknowledge the receipt of both Addendum #1.
