# Annual Town Meeting - May 13

# Annual Town Meeting Warrant will be available at the end of April

Annual Town Meeting is scheduled for May 13, 2024 at 7 PM at Swallow Union Elementary School. The warrant will include a variety of projects, programs, and a revised FY25 operating budget.

Many of the projects included on the Annual Town Meeting Warrant are planned to be funded through Community Preservation Act (CPA) funds. CPA funds can be used for 3 purposes: affordable housing, historic preservation, and open space/recreation. The CPA projects being proposed at Annual Town Meeting, as recommended by the Community Preservation Committee are as follows:

- Removal of Invasive Weeds at Lake Massapoag
- Renovation of Wells at Larter Field
- Town Center Trail Loop Feasibility Study
- Union School Building Restoration and Rehabilitation
- Town Hall Chimney and Roof
   Repairs
- Tennis Courts at Larter Field
- High Street Property

Conservation Restriction Purchase

The warrant will also include a revised FY25 operating budget. The FY25 budget has been modified from the previously approved budget at the Special Town Meeting held on March 26, 2024 due to the general fund override request failing at the ballot on April 2. You can find more information on the FY25 budget at https://www.dunstablema.gov/budget.

Also on the warrant are capital projects requested to be funded through the tax levy. Lastly, the Town is requesting permission to consider a Municipal Electricity Aggregation program for residents and establish an Elderly and Disabled Taxation Fund for the purpose of defraying real estate taxes of elderly and disabled persons of low income. The latter would allow residents to make voluntary donations to a fund administered by a Trust Fund Board to offset tax increases to seniors and disabled residents.

## Municipal Vulnerability Preparedness Plan process wrapping up

#### Listening Session held on April 11; resident survey on draft plan closed April 19

For close to a year, Town staff and stakeholders have worked with the community to develop a Municipal Vulnerability Preparedness (MVP) Plan and also to update the Town's Hazard Mitigation Plan (HMP), made possible thanks to a \$37,000 grant from the Executive Office of Energy and Environmental Affairs (EOEEA). This work has included completing a community resiliency and hazard mitigation planning process and examining the community's vulnerabilities and strengths and identifying priority actions to build resilience as the climate changes.

Communities that complete the MVP

program become certified as an MVP community and are eligible for MVP Action Grant funding and other opportunities to address vulnerabilities identified through this process.

#### Dunstable Housing Production Plan approved by state

The Executive Office of Housing and Livable Communities (EOHLC) has approved the Dunstable Housing Production Plan (HPP) pursuant to 760 CMR 56.03(4). The effective date for the HPP is April 1, 2024, the date that EOHLC received a complete (revised) plan submission based on comments received from the state. The HPP has a five-year term and will expire on March 31, 2029.

Great job by the Town's Affordable Housing Committee for all of their hard work ushering the HPP to the finish line.

### Dunstable and Pepperell issue RFP for Electric Vehicle Charging Stations

#### Proposals due May 9, 2024

The Towns of Dunstable and Pepperell, with the help of Northern Middlesex Council of Governments (NMCOG), have issued a Request for Proposals (RFP) for the purchase and installation of electric vehicle charging stations to enhance public charging infrastructure and accessibility in both communities. Responses to the RFP are due May 9, 2024.

In Dunstable, the Town is seeking to install two EV Charging Stations at Town Hall, 511 Main Street. This project is made possible thanks to a regional transportation grant in the amount of \$42,000.



### SPECIAL ELECTION RESULTS

#### Special Election voter turnout - 47%

On April 2, Dunstable residents voted against a 3-year general override request for just shy of \$2.1 million, 648 against and 520 in favor. Thank you to all Dunstable voters for voting in large numbers - 47% turnout!

Due to the override failing at the polls, Town officials will present a modified FY25 budget at Annual Town Meeting on May 13, 2024.

#### Town awarded Green Communities Grant



The Town was awarded a \$5,000 Green Communities Grant to support the purchase of a new hybrid police cruiser in FY25.

#### Police Station Floor Replacement Complete

This month, work to replace the Police Station floor was completed. The work included the installation of heavy-duty vinyl tile in the lobby, kitchen, and bathroom areas. The main area of the station floor was replaced with carpet tile which will make for easier maintenance and repair in the future. The total cost of the project was \$13,855 substantially less than the estimated \$23,000.

#### Pepperell receives grant for regional PFAS mitigation project

The Town of Pepperell has been awarded a \$5.175 million grant from the Massachusetts Department of Environmental Protection to support the regional PFAS Mitigation Project. This funding is anticipated to be primarily used to offset the costs associated with "Phase 2 West", which includes the connection in Pepperell at Jersey Street, to the Pepperell/Groton town line, and from North Street in Groton to Kemp Street in Dunstable.

The Phase 2 cost portion of the project was originally estimated in excess of \$3.1 million. The Town of Dunstable was responsible for covering 50% of the total cost or \$1.55 million. Based upon this preliminary cost, Dunstable's portion of the project would cost the Town \$51,667 annually over the term of the loan (30 years) which was estimated to increase the average single family tax bill by \$41.44. If the estimated project cost holds for this portion of the project, this grant will likely remove this cost to the Town of Dunstable entirely.

As a reminder, Phase 1 of this project connects Chicopee Row in Groton to the Groton Dunstable Regional School District, continues on Chicopee Row to Groton Street in Dunstable, then connects Groton Street to Kemp Street in Dunstable to North Street in Groton. This portion of the project is estimated to cost \$12.8 million, with the Town of Dunstable covering \$1,863,000 or 14.6%. The impact of the Phase 1 portion of the project, costing the Town an estimated \$62,100 annually, increasing the average single family tax bill by \$47.36, would remain.

The collaboration and regional approach between the Towns of Dunstable, Pepperell, and Groton, as well as the partnership with MassDEP, made this possible. Great work to all involved!

# Union Building re-use planning process update

The Union Building Rehabilitation Committee is close to completing its work to determine viable re-use options for the Union School Building.

To determine re-use options, over the last several months, the Committee has worked with Northern Middlesex Council of Governments and architects, Spencer Preservation Group. As a result of their work, the Committee is finalizing a report which will evaluate potential uses, necessary repairs and upgrades, grant and funding opportunities for supporting viable adaptive reuse options of the building, and makes recommendations.

The Committee led an extensive public engagement process with public meetings and a survey, the results of which will help inform the final report and its recommendations.

#### **Community Preservaton Act in Dunstable**

Dunstable voted to adopt the Community Preservation Act (CPA) in 2006 allowing the addition of a 3% surcharge on local property taxes. When combined with annual matching funds, at variable rates, from the statewide Community Preservation Trust Fund, this dedicated fund is only used for recreation & open space, local affordable housing and historic buildings/resources preservation purposes.

The CPA has allowed the town to complete 51 projects thus far, the first being the purchase of Flat Rock Hill, aka Ferrari Farm. Others include the new playground, restoration of the Town Hall roof, MUD District infrastructure/development, Middle School track, National Register Project for Town Center, Central Cemetery monuments restoration, purchase of land (Howards Brook, Best Triangle, Kendal Cranberry Bog) and of Conservation Restrictions (Frye, Emory, Tully, Miller) to name a few. Without the availability of CPA funds, these projects, and many others, would not have been possible.

#### Planning to replace the Joint Grass Brook Culvert underway

The Town has engaged Hoyle Tanner to assist in the design, engineering, and permitting of a new culvert at Joint Grass Brook on Main Street. This work is being funded through a state earmark in the amount of \$250,000.



#### Municipal Electricity Aggregation currently being considered

The Town is currently considering asking Town Meeting to allow Dunstable to pursue the creation of a Municipal Electricity Aggregation program for its residents.
