To either of the Constables of the Town of Dunstable in the County of Middlesex:

GREETINGS

IN THE NAME OF the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and town affairs, to meet at the Swallow School in said Dunstable on Tuesday, the Seventh of November next, at seven o'clock in the evening, and thereafter continuing from day to day until completed, then and there to act on the following articles:

ARTICLE 1 - Fiscal Year 2018 Free Cash: To see if the Town will vote to transfer from Free Cash (Surplus Revenue) \$315.25 (three hundred and fifteen dollars and twenty-five cents) or some other sum of money for the purpose of paying unpaid bills of FY2017 as follows:

Greenscape Land Design Inc. \$ 119.00 Dave's Septic service \$ 64.76 All Sports Heroes \$ 131.49

or take any action in relation thereto.

- ARTICLE 2 Fiscal Year 2018 Free Cash: To see if the Town will vote to transfer from Free Cash (Surplus Revenue) \$35,000 (thirty five thousand dollars) or some other sum of money to fund the FY2018-2020 NEPBA Local #7 Collective Bargaining Agreement, or take any action in relation thereto.
- ARTICLE 3 Fiscal Year 2018 Free Cash: To see if the Town will vote to transfer from Free Cash (Surplus Revenue) \$3,500 (three thousand five hundred dollars) or some other sum of money to hire an actuary to analyze the Town's OPEB obligation if the Town were to offer retiree health insurance, or take any action in relation thereto.
- ARTICLE 4 Fiscal Year 2018 Free Cash: To see if the Town will vote to transfer from Free Cash (Surplus Revenue) \$29,466 (twenty nine thousand four hundred and sixty six dollars) or some other sum of money to replace the boilers at Town Hall, or take any action in relation thereto.
- ARTICLE 5 Transfer for Repair Water Enterprise Fund: To see if the Town will vote to transfer \$28,098 (twenty eight thousand ninety eight dollars) or some other sum of money to account 6500-04-451-5240-2010-002 from retained earnings in the Water Enterprise Fund, for the purpose of funding major repairs to existing water equipment or other existing water capital assets as deemed necessary by the Board of Water Commissioners, or take any other action relative thereto.

- ARTICLE 6 GDRSD Capital Stabilization: To see if the Town will vote to authorize the Groton-Dunstable Regional School District Committee to establish a Stabilization Fund for the Groton-Dunstable Regional School District, pursuant to Section 16G½ of Chapter 71 of the Massachusetts General Laws, said Stabilization Fund to be invested and to retain its own interest earnings as provided by law, and to authorize an operational line item in the FY 2018 Groton-Dunstable Regional School District budget for the transfer of available monies into said Stabilization Fund, or take any other action relative thereto.
- **ARTICLE 7 - Public Safety Building Parcel Donation:** To see if the Town will vote to authorize the Selectmen to accept a donation of real property located at 108 and 114 Pleasant Street in Dunstable for the construction, use, and maintenance of a Public Safety Building, associated water system improvements, and other uses determined by the Board of Selectmen and the donor, or take any action in relation thereto.
- ARTICLE 8 Public Safety Building Closing and Title Costs: To see if the Town will vote to transfer from Free Cash (Surplus Revenue) \$5,925 (five thousand nine hundred and twenty five dollars) or some other sum of money for closing and title costs associated with the Town's acceptance of a donation of real property located at 108 and 114 Pleasant Street in Dunstable, or take any action in relation thereto.
- ARTICLE 9 Fiscal Year 2018 Free Cash: To see if the Town will vote to transfer from Free Cash (Surplus Revenue) \$9,460 (nine thousand four hundred and sixty dollars) or some other sum of money for the survey of I land related to a new Public Safety Building and associated water system improvements, or take any action in relation thereto.
- ARTICLE 10 Fiscal Year 2018 Free Cash: To see if the Town will vote to transfer from Free Cash (Surplus Revenue) \$17,500 (seventeen thousand five hundred dollars) or some other sum of money for a Market Analysis to inform future economic development decisions, or take any action in relation thereto.
- ARTICLE 11 Recreation Music Donation Account: To see if the Town will vote to transfer from the Recreation Music Donation Account 2613-13-630-1040-0000-000 \$482.25 (four hundred and eighty two dollars and twenty five cents) to the Summer Concert Donation Account 2617-13-693-1040-0000-000, thereby dissolving the Recreation Music Donation Account, or take any action in relation thereto.
- ARTICLE 12 Saturday Office Hours: To see if the Town will vote to accept the provisions of M.G.L. c. 41 § 110A relating to Saturday office closure when counting deadlines and filings, thereby making Saturday the equivalent of a legal holiday for purposes of Town business, or take any action in relation thereto.

And you are hereby directed to serve this warrant, by posting attested copies thereof, one at the Post Office and one at the Town Hall in said Dunstable seven days at least before the time of holding such Town Meeting.

Hereof fail not, and make due return of this warrant, with your doings thereon, to the Town Clerk, at the time and place of the meeting as aforesaid.
